Joaquim Soler is a senior clinical psychologist working in a Borderline Personality Unit in the psychiatric service of Hospital de la Santa Creu i Sant Pau in Barcelona, and also Associate Professor in the Autonomous University of Barcelona. He is a DBT therapist since 2001, and also a MBCT therapist. His doctoral thesis was focused on the study of the DBT Skills Training on patients diagnosed with BPD.

He has collaborated and led several founded projects on Borderline Personality Disorders (BPD) targeting assessment, genetics and psychological and pharmacological treatments. He has published more than 50 indexed papers related to BPD, depression and mindfulness and he is associate editor of the journal *Mindfulness & Compassion*.

He is researcher from G-21 in the CIBERSAM (Center of research in Mental Health Network) since its creation in 2007. He is also a principal investigator of the Hospital of Sant Pau group and mindfulness group in the Excellence Network for the dissemination of psychological treatments for mental health promotion in Spain (PROMOSAM) and he has collaborate on national (National Health Department) and international (World Federation of Societies of Biological Psychiatry) Task Forces on Personality Disorders. Joaquim is also a board member of the Spanish Society for the Study of Personality Disorders (SEETP) and more recently president and cofounder of the Spanish DBT Society (SP-DBT).
